
Brittan Elementary Board of Trustees

The five-member board, while composed of individuals, acts officially only as a group. No member or group of members acts in the name of the Board unless authorized by the Board. A majority of the Board constitutes a quorum for the transaction of business. Individual trustees, serving without pay, are elected for four-year terms.

The Board of Trustees holds regular board meetings the second Tuesday of every month beginning at 7:00 p.m. The public is encouraged to attend.
